Just input a few simple pieces of information, such as volunteer's first and last name and date of birth. Submit and you will receive an immediate, easy-to-read report. The report will identify criminal activity along with offense descriptions.

Included with Safety 1st

Safety1st searches a nationwide (not all inclusive) source of data to identify any criminal records that are not revealed searching locations based on addresses where the applicant has lived. Any hits are re-verified at the county where the offense occurred (hits will incur re-verification cost). Safety1st will include information from the following sources: Multi-State Sex Offender Database, the FBI Terrorist List and Federal/State/Local Wanted Fugitive Lists. Safety 1st also searches the Specially Designated Nationals List (SDN List) from The Office of Foreign Assets Control (OFAC). This service identifies organizations or individuals linked to illegal trade, terrorism, international narcotics trafficking, and those engaged in activities related to weapons of mass destruction. This service helps impede terrorists by identifying individuals linked to terrorism or classified on government watch lists, improving compliance with the United States Patriot Act.

CrimAlert CrimAlert is a proprietary post-employment tool that is customized to notify you when something changes that relates to the criminal activity of your volunteers or employees, helping you create a safer work environment. We will customize a solution based on your specific needs, to either scan the nationwide criminal database on a regular basis or run a county or statewide criminal history check on a quarterly or semi-annual basis. Stay informed on what happens once you hire an employee. *(may require initial use of Safety 1st or CrimNet)* Ask about customized pricing for this service.
